Discussion: Councilor Hoffman Saccoman requested a change in the wording of the Employment Contract; Councilor Bayliss agreed.

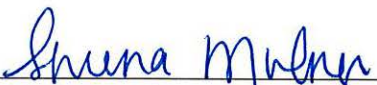
