City Engineer Jesse Story explained that they opened the bids for the 2021 Paving Project on April 6, 2021. The following bids were opened:

The low bid was from KGM Contractors in the amount of \$1,833,916.25. This includes State Aid segments and City Segments as follows:

You can see that we are about \$107,000 short for the Municipal State Aid. When we do these projects, we estimate a little heavy on them so we don't come low for the budget. If we do end up a little short, we can borrow from next year, but we will wait until we get the payment in January of 2022 and we can submit for that reimbursement.

We are under budget on the City's portion.

City Engineer Jesse Story explained that there are two quotes for an Auger Attachment for the Cemetery Backhoe:

This auger attachment would be used for cremations. Originally this was a budgeted item and the amount that was originally budgeted for was \$15,900. It was crossed out of the budget. Mr. Story had the older budget, not the new budget where this was crossed off. Going through the Cemetery budget, we can pull funds from the 200 budget (office supplies), 210 budget (operating supplies), and 220 budget (repair and maintenance) to cover the cost of this item.

We need a topper on that pickup to protect the survey equipment.

Authorize the Mayor and City Clerk-Treasurer to sign the Use Agreement for Operation of the Mine View

City Attorney Andy Borland explained that this afternoon in the add-on packet, you should have received a document entitled a Mine View Management and Maintenance Agreement. At the last City Council Meeting, the City Council approved a grant through the State for the money to actually go ahead and build some of the infrastructure with regard to the Mine View. One of those references in there made reference to what is called a Use Agreement. It is a little bit unique in interpretation whether or not the Use Agreement truly meant using or operating the Mine View but for purposes to make sure we get this passed, Mr. Borland talked with the City Administrator and he wanted something in writing between the City of Hibbing and the Tourist Seniors who run the facility throughout the summer. Mr. Borland crafted the Agreement for the Council's consideration. If in fact the City Council wanted to approve this, we would then present this to the Tourist Seniors because they haven't seen it yet. This agreement is also contingent upon also being approved by the State of Minnesota Office of Management and Budget because they are the ones approving the grant. Along with the Maintenance Agreement, you will see a checklist which came from the Office of Management and Budget. He went through the checklist to make sure we cover what they are looking for.

Mr. Borland made sure to put a Hold Harmless Waiver. He wants to make sure that every senior who is nice enough to go up there and volunteer to work to sign that waiver before they work because if they are injured the City has some protection with regard to liability. Mr. Dicklich wanted that incorporated in this agreement.
